Illinois Medicaid Revalidation is completed and approved. Aishah has received the Recertification letter from Illinois Medicaid.

Aishah has been working with IB&T in preparation for bank conversion to UMB.

2. McCartney moved, Miller seconded to increase Galena Area EMS District Ambulance Response Rates for ALS upgrade/intercept.

Board members were provided with a copy of a letter from Elizabeth Community Ambulance Service advising their charge to GAEMSD for an ALS upgrade/intercept will be \$500.00. Their last increase to us was in May 2022. Board members were also provided with a chart showing the changes.

The increases will be **effective retro-actively to July 1, 2025**.
